What is an MRI?

- Magnetic Resonance Imaging (MRI) is a non-invasive way to look inside your body without using X-rays. Instead, it uses a magnet, radio waves and a computer to scan your body and produce detailed pictures that cannot be seen on conventional X-ray.
- Once a decision to image the patient has been made based on the outcome of a history and physical examination of the patient, there are four important elements we consider when ordering and performing the neuroimaging.
- 1) The careful selection of which body part to image and the selection of the particular MRI or MRA protocol and sequences needed to evaluate the patient's symptoms.
- 2) The use of highly trained and experienced certified technicians even the best equipment does not insure that the image quality will be achieved without the experience of qualified technicians.
- 3) The use of an accredited (ACR or ICAMRL) Neuroimaging Center this assures that the equipment and procedures used meet a high level of competency and that procedures are in place to constantly evaluate and improve quality.
- 4) Fellowship trained or Board Certified Neuroimaging/Neuroradiologist interpreting the images. A general radiologist who is minimally trained in MRI and in particular central nervous system MRI will not give us the quality we expect or patients deserve.

What can I expect?

• When you arrive, a technologist will ask you to remove anything metallic such as a hearing aid, partial plate, jewelry or hairpins. Ladies, if you are having a MRI Brain or MRA Circle of Willis, please do not wear any make-up. You can store your credit cards, watches, coins and keys in a lock-box for safekeeping. You may be asked to fill out a safety questionnaire if you have not already done so. Please arrive at the time listed on the front of your MRI packet.

What happens during the examination?

 A technologist will assist you onto an automatic scanning table. You will lie on your back for the duration of the exam. It is important that you do not move during the exam. The table will then slide into the opening of the magnet. You will not feel a thing, but you will hear a bumping and knocking noise and the turn of the machine. This is normal.

How long does it take?

 The length of the time your examination will take varies depending on what test(s) your doctor ordered. For example:

It is not unusual for your doctor to order more than one MRI or MRA exam. If your testing should take more than **30 minutes**, you should limit the amount of fluids you drink on the day of the exam.

When a contrast agent is needed

In some cases, your doctor may order a contrast (imaging enhancement) agent.
This is a fluid injected into a vein. It will usually be done during the latter part of your
exam. It helps to make the details in MRI images clearer and is standard procedure
for some types of MRI scans.

When a duplicate copy of scan is needed

• The first copy of scan(s) is provided at no charge to the patient. If additional copies are needed, the charge is \$7.50 and is due at time of order. Please allow a minimum of 48 hours for copies.
